**POSITION PURPOSE:** The Surveillance Operator is responsible in detecting disturbances and compliance violations of the Seminole Nation Casinos set forth by the Minimum Internal Control Standards, Tribal Internal Control Standards, Seminole Nation Gaming Enterprise Policies and Procedures. The Surveillance Operator uses closed circuit television monitors, NVRs and cameras to help protect the assets of the Seminole Nation of Oklahoma by performing and following these duties. Observe and report any and all activities related to gaming.

**QUALIFICATIONS:** Must have a high school diploma. One to two years' experience in the casino environment. Ability to operate various computer software applications and DVR equipment. Must be able to pass the required background investigations requirements. Must not have a criminal record and possess a valid Oklahoma's driver's license.
